**In 2025, the NEC Society distributed nearly 1000 resources to families and NICUs across the United States, presented the world's largest conference on necrotizing enterocolitis, the NEC Symposium, which attracted nearly 250 participants, built and launched new resources for NICU families in partnership with the Children's Hospitals Neonatal Consortium, spoke at educational conferences every month across the US and around the globe, and launched the NEC Glossary to empower our community with information to understand necrotizing enterocolitis.**

**In 2025, the NEC Society helped the NEC Biorepository increase enrollment to 1,139 babies, launched the NEC Registry, expanded the NEC Research Incubator to 200+ participants and hosted research roundtables, presented at the Pediatric Academic Societies Meeting, contributed to several research publications and projects, and funded three research awards to attract and support clinicians and scientists studying NEC.**

**In 2025, the NEC Society participated in the NICU Parent Network's Advocacy Day in Washington DC, the March of Dimes Advocacy Summit also in DC, continued engagement with the FDA to push for better treatment options for babies at risk of and affected by NEC, passed NEC Awareness Day Resolutions in New Jersey and South Carolina, held 22 awareness events across the US during May's NEC Awareness Month, and launched our first-ever YOLO Run for a world without NEC to inspire more people to get involved in the NEC Society's work for babies and families.**
